WHEREAS, a final budget has been prepared estimating expenditure and revenues of the Town for the ensuing year, with detailed information, including revenues to be derived from sources other than ad valorem levy, and recommendations have been made as to the amount to be appropriated for the ensuing year; and

WHEREAS, the Town Commission of the Town of Hillsboro Beach, Florida has conducted a public hearing and has considered recommendations and the proposed millage to be levied to carry on the government of the Town for the ensuing year;

Section 1. Each of the "WHEREAS" clauses set forth above are true and correct and herein incorporated by this reference.

Section 2. The final millage rate necessary to be levied against ad valorem valuation of property subject to taxation in the Town of Hillsboro Beach, Florida, to produce a sufficient sum which together with departmental and other revenues will be sufficient to pay for appropriations made in the final budget for the fiscal year is hereby set at 3.50 mills.

Section 3. The final millage adopted herein is greater than the rolled-back rate computed pursuant to the TRIM Act (Section 200.065, Florida Statutes, 2010, as amended) by _____%.

Section 4. If any clause, section or other part of this Resolution shall be held by any court of competent jurisdiction to be unconstitutional or invalid, such unconstitutional or invalid part shall be considered as eliminated and shall in no way affect the validity of the remaining portions of this Resolution.

Section 5. All Resolutions or parts of Resolutions in conflict herewith are hereby repealed to the extent of such conflict.

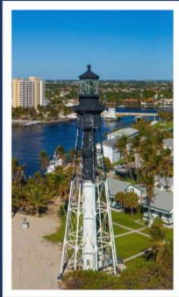

BUDGET CHANGES

The following changes were made to the budget since the 1st public hearing:

- **City Clerk Department (page #45)**
 - Increased Contracts - Minutes Preparation budget by \$1,100 (From \$3,000 to \$4,100).
 - Added budget for Temporary labor - \$6,500. Estimate for 1st quarter (Oct – Dec).
 - Reduced total hours on the Administrative Assistant Position (From 2080 hours to 1560). The reduced hours resulted in a budget decrease of \$16,623 (offset by temp labor budget).
- **Police Department (page #51)**
 - Increased Legal budget by \$5,000 for PBA negotiation (From \$5,000 to \$10,000).
 - Increased Contracts – Other Services by \$5,000 for additional contracts / price changes (From \$24,406 to \$29,406).
- **Insurance Premiums (page #20, 51, 55 & 95)**
 - Reduced Worker's Compensation budget by \$5,673 based on FY2022 FMIT quote (From \$57,111 to \$51,438).
 - Reduced General Liability / Property / Liability / Auto Premiums budget by \$21,982 based on FY2022 FMIT quote. (From \$107,376 to \$85,394).
- **Marine Grant (page #71)**
 - Increased grant amount by \$6,944 (From \$30,336 to \$37,280).

- **Contingency (page #65 & 95)**
 - Increased General Fund Contingency budget by \$21,477 (From \$188,179 to \$209,655).
 - Added Water Fund Contingency budget by \$92,295 (From \$0 to \$92,295).
- **Building / Permitting Fund (page #74)**
 - Increased budgeted Revenue & Expenditures by \$100,000 (From \$405,000 to \$505,000).
- **General Fund – Capital Improvement Program (page #85)**
 - Reduced loan amount for Hurricane Dorian Project by \$566,875 (From \$1,137,500 to \$570,625).
 - Increased FEMA grant for Hurricane Dorian Project by \$566,875 (From \$3,499,970 to \$4,066,845).
- **Water Fund – Capital Improvement Program (page #103)**
 - Reduced cost of AIA Redesign project by \$275,761 (From \$450,000 to \$174,239).
 - Increased American Rescue Plan Act grant amount by \$53,859 (From \$450,000 to \$503,859).
 - Removed State Revolving Loan budget (From \$1,160,000 to \$0).
 - Reduced Transfer-in budget by \$79,620 (From \$121,346 to \$41,726).
 - Split Storage Reservoir project out over two fiscal year to mirror projects grant funding.

OTHER BUDGET NOTES / ASSUMPTIONS

- The FY 2022 budget was developed using the FY 2021 service levels as a starting point.
- The General Fund and Water Fund budgets were balanced without needing to use reserves.
- **Staffing Plan**
 - Police Department - Added 2 new marine Reserve (P/T) positions - \$35,546. Additional positions required to operate boat during weekend, holiday, and weekday hours.
 - Water Department – Removed 1 P/T position - \$25,059.
- **Compensation**
 - Step Increase – \$14,894 / COLA Increases – \$97,081 (Includes Wages & Benefits). Per Police agreement, a cap of 3% was included in the budget.
 - FRS Net Increase – \$31,600.
 - Health Premiums – 15% – \$64,180 (Rate Increase Estimated)
 - Life, Vision & Dental Premiums – 10% – \$2,779 (Rate Increase Estimated)
 - Workers Comp Premiums – Reduced to \$51,438 based on FY2022 FMIT quote.

 - \$60,000 for Town Hall Renovation Projects.
 - \$4,565,000 for Hurricane Dorian Beach Mitigation Project (87.5% FEMA funding).
 - Annual Budget for Project-related Beach Management - \$72,470 (100% FEMA funding).
- **Water Fund Capital Improvement Program (CIP) decreased from \$713,500 in FY 2021 to \$559,239 in FY 2022.**
 - \$40,000 for Utility Truck.
 - \$120,000 for Well Rehabilitation / \$100,000 for Storage Reservoir.
 - \$174,239 for A1A Design & Relocation Project (American Rescue Plan Grant)
 - \$30,000 for Mobile Home Repairs (Partial funded by Insurance Reimbursement)
 - \$30,000 for Perimeter Fence Rehab / \$65,000 for Repairs & Renewal Projects.

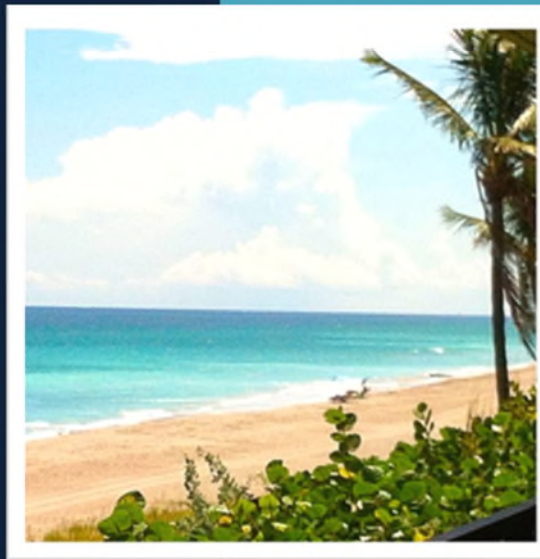

Subject: Fiscal Year 2022 Annual Town Budget

In accordance with Article IV, Section 5(5.c) of the Town's Charter, it is with great pleasure that I present the Town's Budget and Capital Plan for Fiscal Year 2022, which begins on October 1, 2021 and ends on September 30, 2022. Included in this budget book are financial tables, graphs and documentation in regard to missions, accomplishments, and goals to incentivize continuing improvement. This information provides a review of the Town's historical financial experience, plus a look forward to the challenges and opportunities that we are likely to face as we continue to move the Town along the path established by the Mayor and Commission. Together, the graphs, tables and documents are assembled to communicate the recommended priorities and focus of the Town's staff and financial resources.

Many of the enhancements first introduced back in the 2019 budget were continued in the 2022 budget; always with the goal of making the document easier to read, complying with charter requirements, providing a greater level of detail and organizing the data into sections that assist the reader with analyzing the financial results of the various Town operations.

To begin with, the same fund and department structure was maintained in the 2022 budget. As a brief review, below are the recent funds created and included in this budget:

- Special Revenue Fund: includes items where the funding is dedicated to a specific type of activity. This includes the Community Bus program (funded by grants and Local Option Gas Tax revenue) and Permitting, Planning & Zoning and Code Compliance activity (funded by Permit and Planning & Zoning fees).
- FEMA Loan Fund: used to account for the annual payment of the principal and interest for the loan obtained by the Town to pay for the 2020 beach nourishment. This fund will not have a budget for FY 2022.
- General Fund - Capital Improvement Program (CIP): includes all General Fund capital expenditures and is used to plan capital requirements five years into the future. Capital projects are defined as items greater than \$1,000 with a useful life greater than one year.
- Water Debt Service Fund: used to account for the annual payment of the principal and interest for the loans obtained by the Town to pay for the water plant expansion and water main replacement projects.
- Water Fund - Capital Improvement Program (CIP): includes all Water Fund capital expenditures and is used to plan capital requirements five years into the future.

From a financial perspective, the Town remains very strong, even with the expenditures incurred for the beach litigation. As discussed elsewhere, even though Town finances are reported in eleven funds, nine are ancillary funds primarily dependent on the General Fund and Water Fund for funding. Consequently, the General Fund and the Water Fund are the best indicators of the Town's overall financial health.

Based on the above table, the following are pertinent observations:

Revenue / Transfer In – The FY 2022 budget is expected to increase by 6% compared to this year primarily due to a 4.38% growth in the tax base with a tax (millage) rate of 3.5000 mills.

Use of Fund Balance – The fund is not expected to use fund balance in FY 2021 due to settlement of the beach litigation and lower than budgeted capital spending. The General fund is not budgeted to use fund balance in FY 2022.

Expenditures – (Excluding Contingency) – The FY 2022 budget is significantly lower than FY 2021 primarily due to the settlement of the beach litigation. These decreases will be offset by an increase in the Fire contract as well personnel costs.

Contingency – A contingency amount of \$209,655 is available in FY 2022 for Commission consideration. This amount can be used for initiatives not currently reflected in the proposed budget.

Closing Fund Balance – Primarily due to the completion of the beach litigation as well as lower than anticipated capital spending, the fund balance is forecasted to increase in FY 2021. By the end of FY 2022, the fund balance is expected to be 57% of the FY 2022 expenditures. A percentage of 25% (equivalent to three months of operation) is considered to be healthy.

Based on the above table, the following observations are relevant:

Revenue / Transfer In – Lower water usage anticipated in FY 2021. An increase in water usage is included in next year's budget. This increase is offset by the expiration of the Sprint cell tower lease in April 2022.

Use of Fund Balance – FY 2021 is forecasted to utilize \$2,645 in fund balance to complete capital projects. The Water fund is not expected to use fund balance in FY 2022, but this assumes the water usage rebounds back to pre-pandemic levels as well as receipt of anticipated grant funds.

Expenses – FY 2021 is forecasted below budget due to the unspent contingency line. The FY 2022 budget include approximately \$92,295 for contingency expenses.

Closing Fund Balance – Between FY2021 and FY 2022, the balance is expected to decrease by approximately \$2,645 due to anticipated capital spending. At that point the closing fund balance will be 121% of the FY 2022 Water Fund expenses when a percentage of 25% is considered to be healthy.

The budget book provides additional details in regard to the FY 2021 forecasted results and the proposed FY 2022 recommended budget.

FY 2021 Highlights

This past year was a challenging one with the pandemic requiring the entire Town to re-think and adjust our day-to-day activities. In spite of these challenges, the following is a summary of some of the accomplishments in response to your direction.

- Maintained workforce and continued service levels during pandemic, while experiencing staffing issues with exposed and positive-testing workforce.
- Transitioned to virtual and then hybrid meetings.
- Worked with the Department of Health to create a vaccination site at Town Hall.

- Coordinated with Deerfield the selection of engineer for joint beach project and currently working on a nourishment project that includes Boca Raton, Deerfield.
- Qualified Town for FEMA funding for next beach nourishment project due to Hurricane Dorian damages. Currently securing FEMA funding (87.5%) for FY2022 (~\$4.2M estimated project cost). Currently assisting in funding obligation for beach and hazard mitigation funds.
- Pursuing FEMA approval for \$4.2 million for hazard mitigation and beach management project.
- \$983,036 DEP grant award for beach nourishment related to Hurricane Irma. This grant is expected to fund the Town's share of the beach nourishment project completed in 2020. Currently processing reimbursement for Town.
- Introduction of a pre-construction process for large projects, to inform contractors of specific local community standards and requirements such as cleaning road shoulder, staff parking and deliveries, and construction hours.
- Website enhancements to increase user awareness of the permitting process.
- Expanded ACH Vendor Payments.
- Revised and continued enhancement of Financial Presentation.
- Initiated Process for online Lobbyist Registration Portal to meet compliance with County requirements.
- Added additional community shredding/HHW events for residents to safely purge/destroy sensitive records and discard paint and solvents.
- Enhanced Bocce Ball courts with new amenities: mats, trashcans, recycle bins, flowers.
- Extended faster Wi-Fi throughout Town Hall.
- Completed three (3) Community Blood Drives.
- Maintained & updated contact database for Condo Property Managers and Board Presidents for monthly Condo Forum.
- Developed Town Reference Guide for Newly Elected Officials.
- Audited Town Website quarterly for State regulatory and ADA compliance.
- Implementing online automated Public Records Request management software by year-end to simplify and track public records requests.
- Implemented a new policy requiring police officers to intervene when unnecessary force is deployed.
- Created a marine task force with the Broward Sheriff's, Florida Fish and Wildlife and Lighthouse Point's, Pompano Beach to address vessel speeding, noise and wake violations.
- Deployed the P25 radio communication system for the Police Department that provides interconnectivity to other departments.
- Revised and enhanced Crosswalk/Pedestrian/Cyclist/Motorist Safety and Enforcement Program.

- Implemented new uniformed computers, with up-to-date devices, several software programs and CJIS Criminal Justice Information Systems databases.
- Deployed body cameras and in-car videos to all patrol cars and officers.
- Replacing all sodium chloride feeders with new units that are easier and cheaper to maintain and operate.

These projects, changes and enhancements were undertaken with a focus of continuing to provide quality service to our residents while prudently spending Town resources, in accordance with the Commission-approved Vision and Mission statements, laying the groundwork for further improvement as the Town moves forward.

Looking Forward to FY 2022

Nothing will be more important than the continued effort to protect the Town's beach. Moving forward with the joint beach project with the City of Deerfield Beach will be an important project for FY2022.

Similar to this year, FY 2022 will focus on several key capital projects and construction. Staff will be continuing their efforts to fully digitize and store all records offsite to provide usable space within the planning room, and improvements to the surrounding parking lot are being developed. In addition, the focus will be to complete the renovations to Town Hall.

A few other key projects for FY 2022 include the beach nourishment project, FDOT's A1A design, and water utility projects that will continue to preserve the Town's water supply. For the beach, the Town is earnestly working on the pre-construction design for a joint beach re-nourishment project. Our coastal engineers will be working on the design plans, obtaining the necessary permits and managing the bid process for our next nourishment with Deerfield. The current funding provides for FEMA/State to contribute 87.5% with the Town matching the remaining 12.5%. As always, staff and our consultants will be investigating and researching alternative funding sources for future beach projects.

Working with our contracted engineer, we will be advocating for the best possible design for A1A, one that raises the road, protects against the effects of king tides and intense rainfall, and safely maintains traffic flow. Our water utility, with its newly replaced distribution system, is looking to expand its finished water tank to provide additional capacity, and to install variable frequency drives that allow for a mixture of raw water from different wells while reducing chemical and electricity costs. The major of the water utility projects will be funded with the American Rescue Plan Act.

In addition to the previously mentioned projects, the goal in FY 2022 is to complete the easement acquisition phase of the underground utility project. Staff will also continue the focus on internal processes, policy review, technology upgrades to key systems and other critical updates of the Town to ensure that the Town continues to adopt best practices.

Finally, as in other years, we have included in this budget book goals for each department for the new budget year. We look forward to hearing feedback from the Commission and community as we work towards providing superior service to our residents.

I would like to thank the entire finance department. This budget book would not be possible without the expertise and tireless efforts of Stephen Bloom and the entire Inframark Team. Thanks are also owed to the entire Town Staff: Chief Szesnat, Elliott Garay, and Sherry Henderson, and our contracted strategic

partners: Waste Pro, BSO Fire Department, Moffatt & Nichol; Calvin, Giordano & Associates, and Redevelopment Management & Associates.

Particular thanks to the Mayor, Vice Mayor and Commissioners for your unwavering leadership, guidance and cooperation in planning and providing the direction for our great Town. It is a pleasure and a gift to be able to be of assistance in your efforts toward moving the Town toward excellence.

Funds Overview

General Fund

- Purpose – This fund provides funding for most ongoing operational activities within the Town other than the Water Department. There is a minimum of “one-off” activities in this fund, allowing for reasonably predictable year-to-year change. Additionally, this fund provides funding to various other funds requiring additional funding as described below.
- Funding Sources – Funding is from taxes, assessments, permits, distributions from other governmental organizations and other miscellaneous sources. Revenue received in this fund isn’t restricted as to how it can be spent, although in other than the most extraordinary circumstances, the General Fund won’t provide funding to activities related to the Water Department.

Special Revenue Funds

- Purpose – Funds focus on those activities for which revenue has been received and can only be spent for specific purposes. This fund matches revenues received to the expenditures for which they were intended. Failure to make the necessary expenditure within a defined period may result in the forfeiture of the revenue.
- Funding Sources – Funding is normally from grants. In many instances the grant is insufficient to cover the expenditure, e.g., a 50-50 match, necessitating an “internal transfer” from the General Fund to fully fund the expenditure.

Debt Service Fund

- Purpose – Debt service funds are established to ensure focus on long-term debt obligations requiring annual funding.
- Funding Sources – Funding is derived from an assessment on the annual property tax bill. This assessment is intended to meet the annual funding requirement. However, an “internal fund transfer” from the General Fund may be occasionally required due to the timing of the assessment funding.

General Fund - Capital Improvement Program (CIP)

- Purpose – This fund allows focus on significant capital investments to be made in various projects and other capital requirements over the next five years. A long-term outlook ensures requirements are identified in a timely way and, since capital expenditures can be large, permits for the necessary planning to ensure funding will be available when the project is to be undertaken.
- Funding Sources – Funding can be derived in part through grants, e.g., FEMA funding of the beach re-nourishment project and loans. However, even if a grant is available in conjunction with a project, it usually won’t cover all costs and an “internal fund transfer” will then be required from the General Fund to fully fund capital expenditures.

Funds Overview

Water Fund - Operations

- Purpose – This fund provides funding for most ongoing operational activities within the Water Department. There is a minimum of “one-off” activities in this fund, allowing for reasonably predictable year-to-year change. Additionally, this fund provides funding to various other Water Department-related funds requiring additional funding as described below. Finally, there also is an “internal fund transfer”, currently \$50,000 per year, to the General Fund as payment for Commission oversight and the financial and other management services provided by General Fund departments.
- Funding Sources – This fund is funded fully from water service fees and other minor miscellaneous revenue sources.

Water Fund - Debt Service

- Purpose – Water debt service funds are established to ensure focus on long-term debt obligations related to the Water Department requiring annual funding.
- Funding Sources – Funding is available in part through a surcharge on the monthly water bill. All remaining required funding occurs from “internal fund transfers” from the Water Fund.

Water Fund - Capital Improvement Program (CIP)

- Purpose – This fund allows focus on capital investments to be made in various projects and other capital requirements over the next five years related to the water department. A long-term outlook ensures requirements are identified in a timely way and, since capital expenditures can be large, permits for the necessary planning to ensure funding will be available when the project is to be undertaken.
- Funding Sources – Funding can be derived in part through grants and loans. However, to the extent that grants and loans may be insufficient, an “internal fund transfer” will be required from the Water Fund to fully fund capital expenditures.

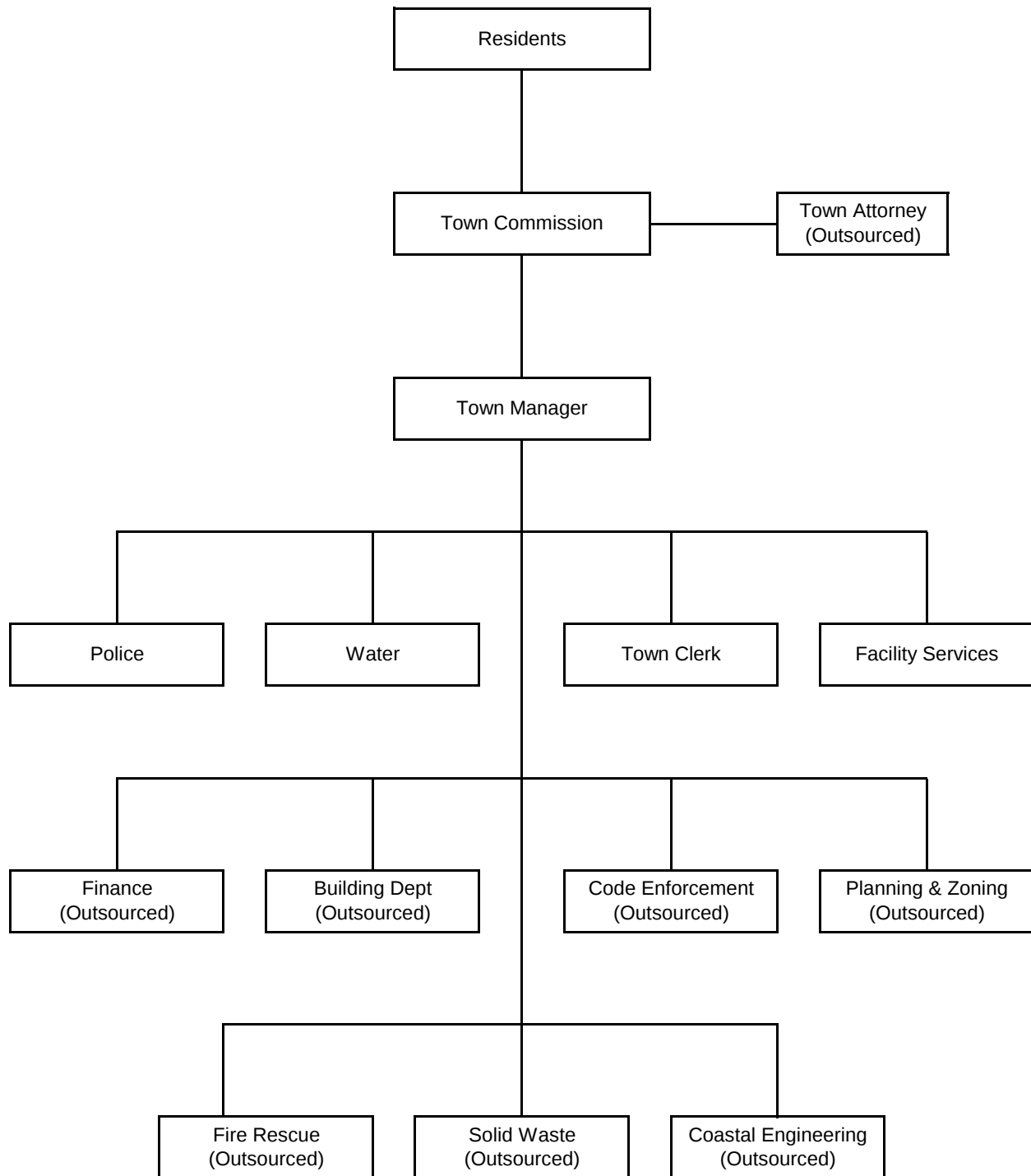

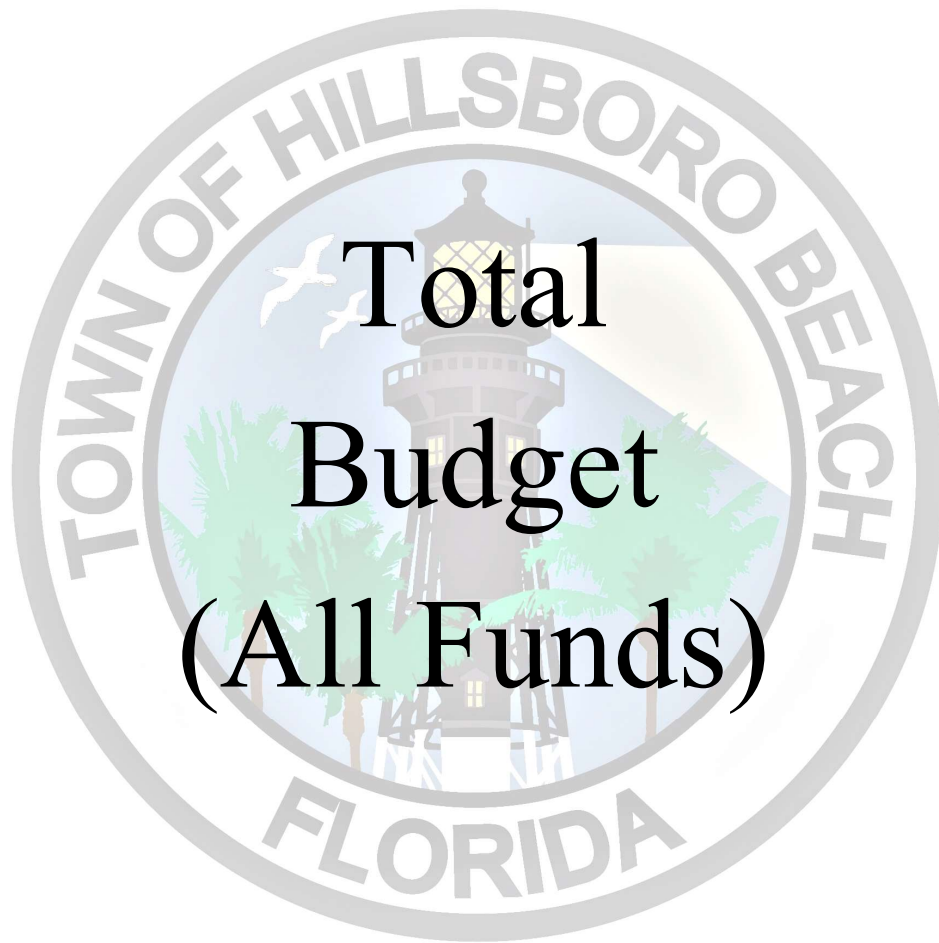
Organizational Chart

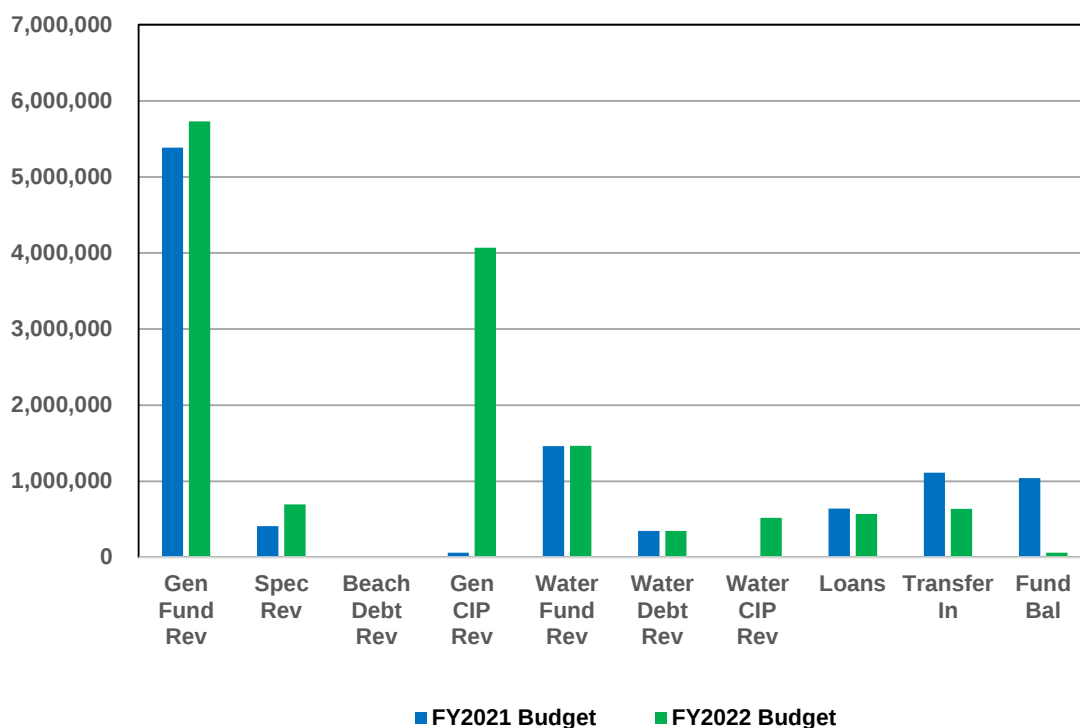

FY 2021 Budget vs. FY 2022 Budget

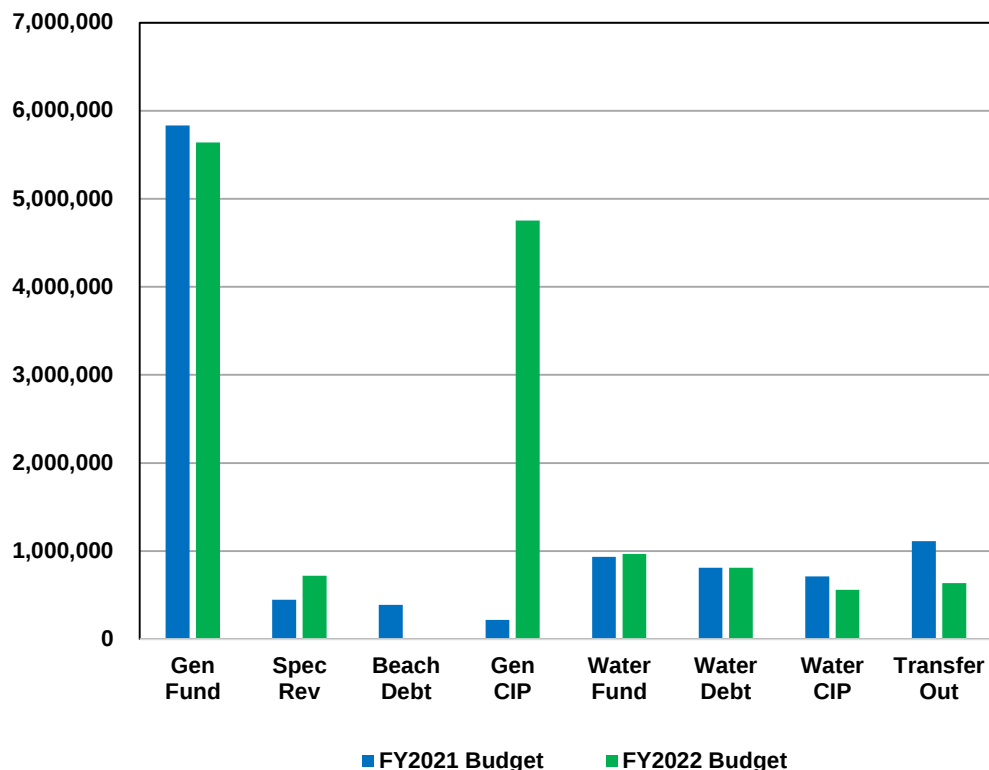

FY2021 Budget vs. FY2022 Budget

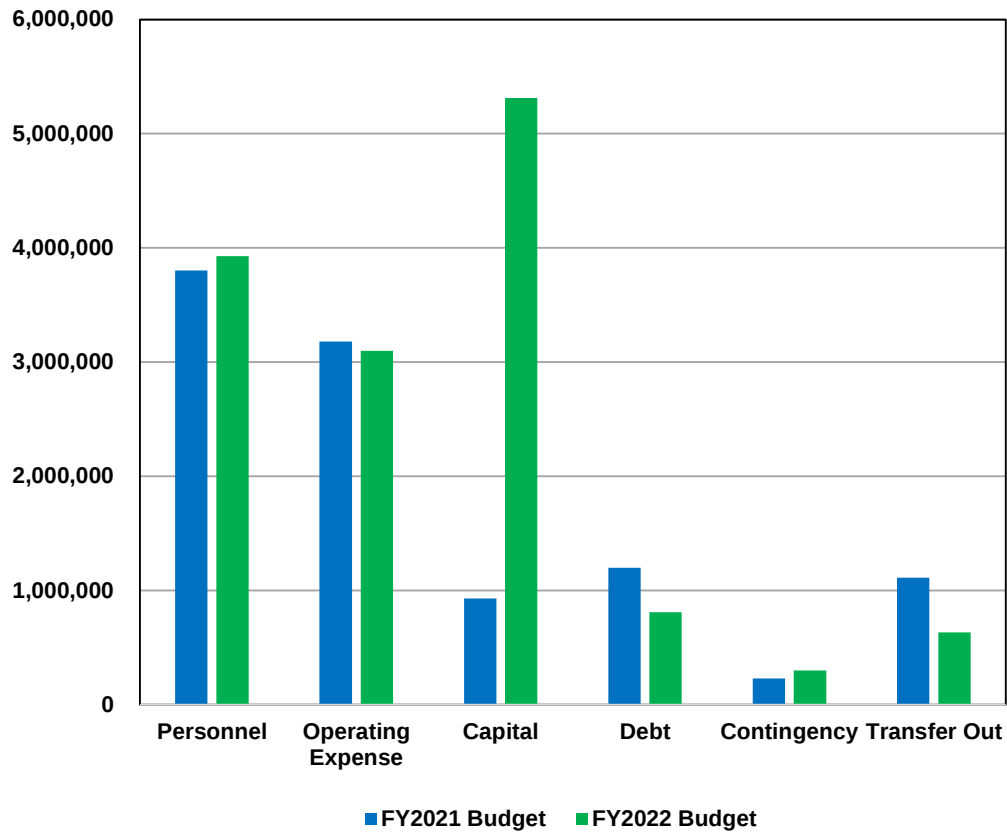

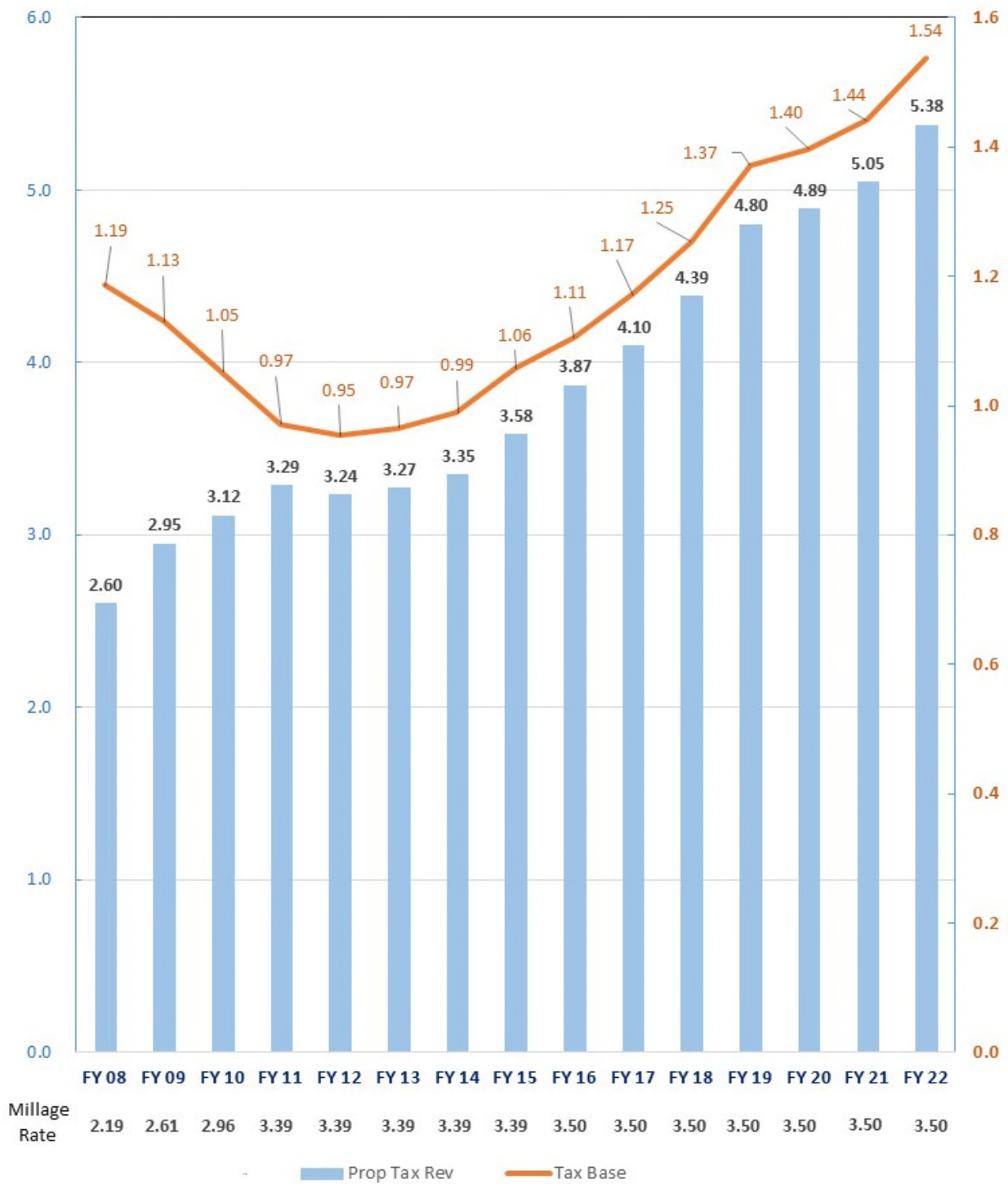

FY2020 Budget vs. FY2021 Budget

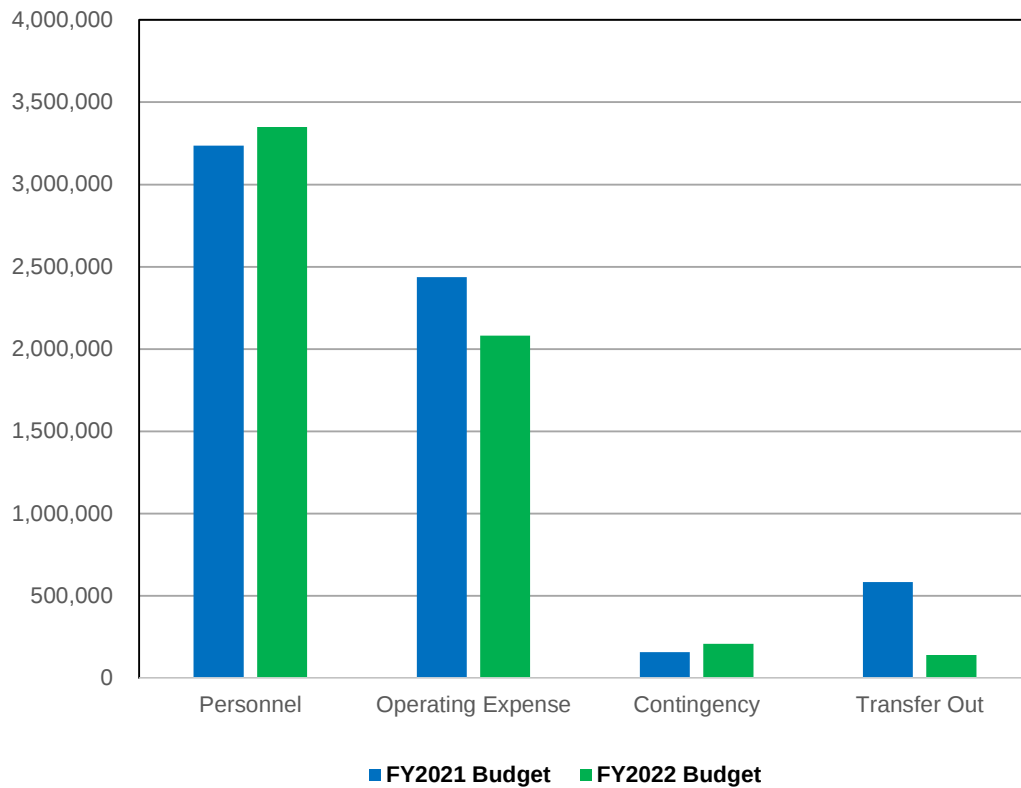

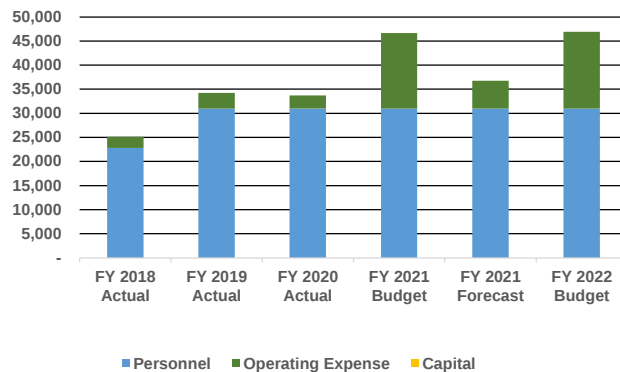

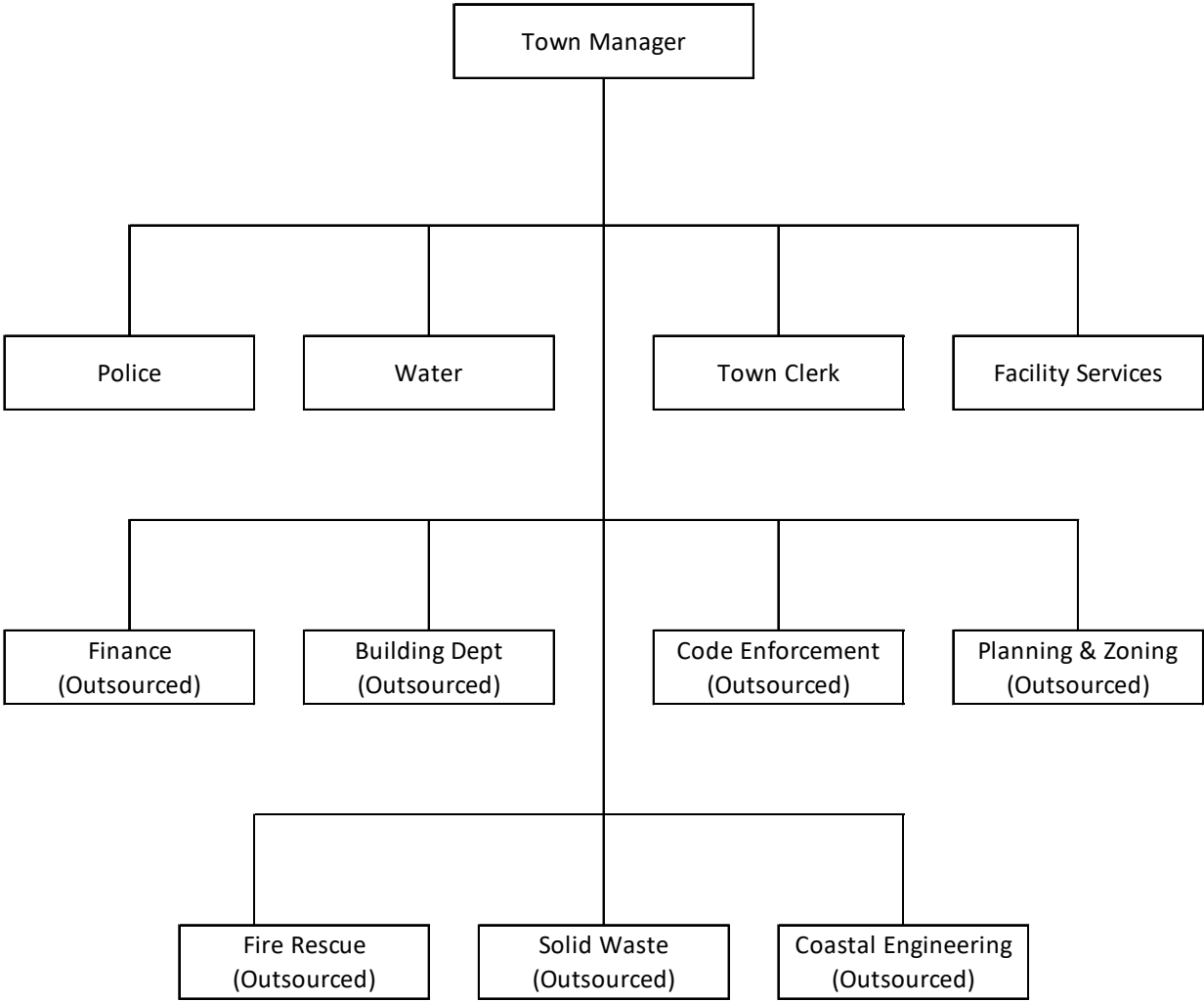

Organizational Chart

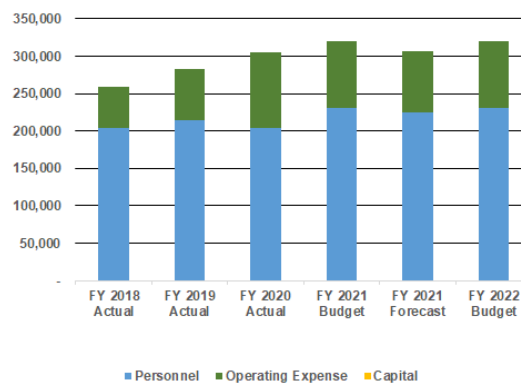

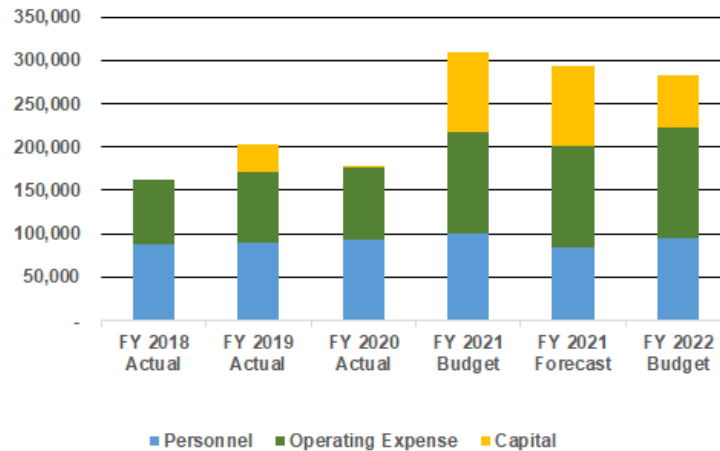
Organizational Chart

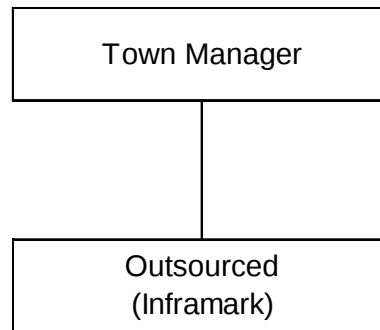

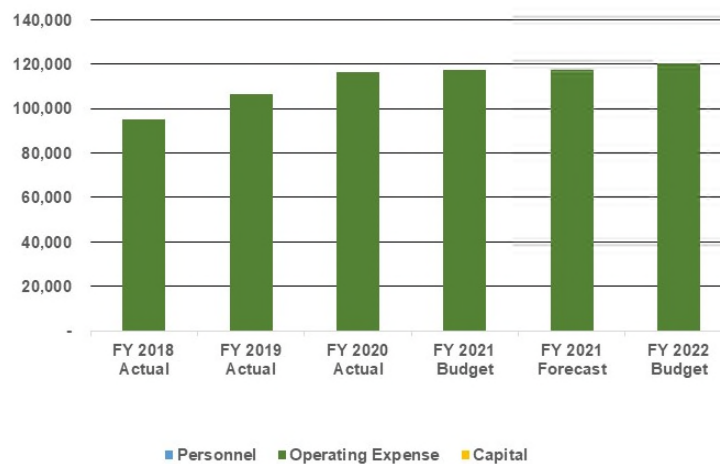

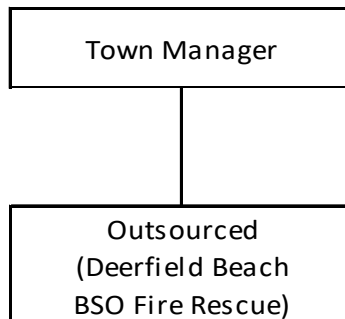

Organizational Chart

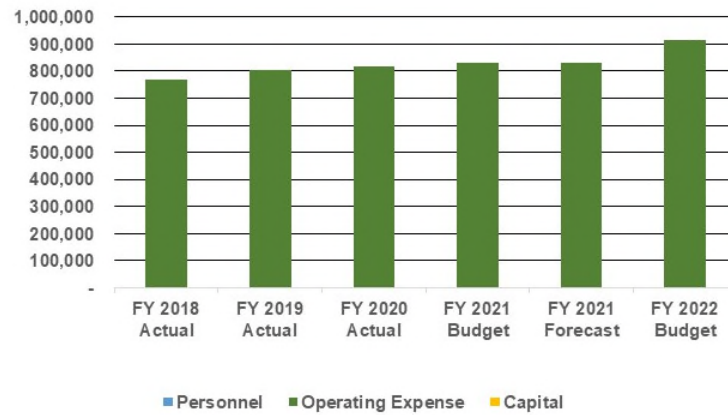

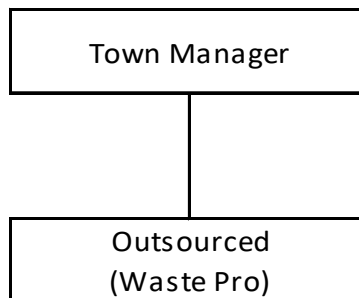

Organizational Chart

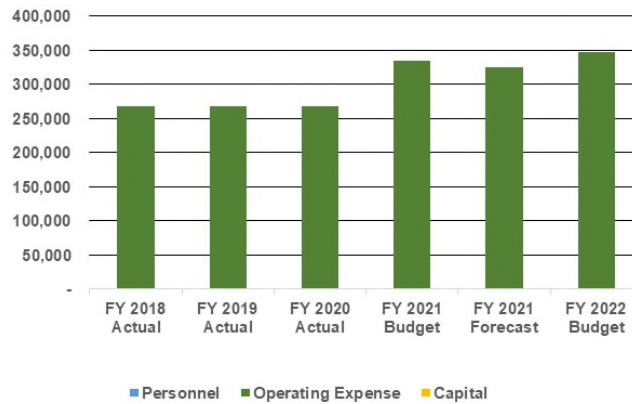

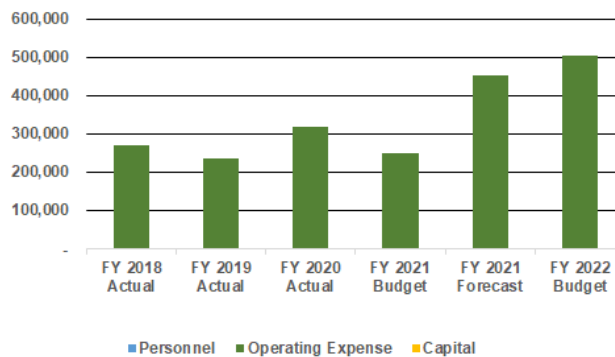
Organizational Chart

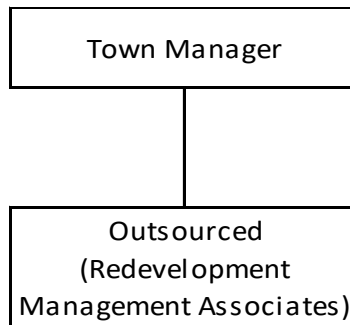

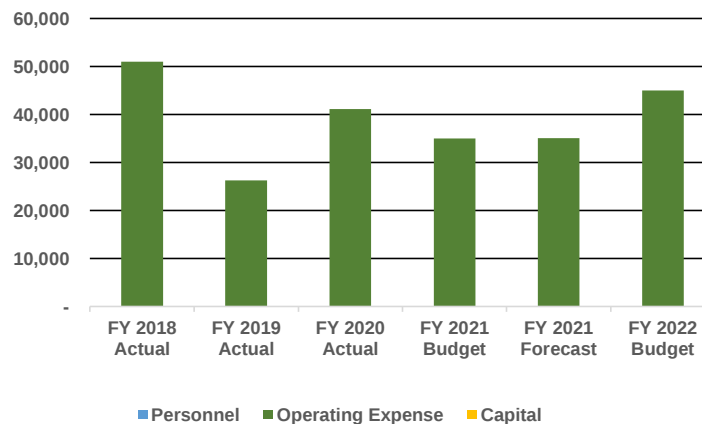
Organizational Chart

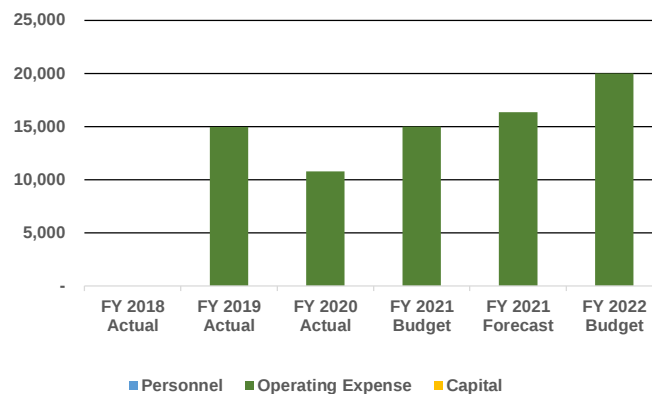

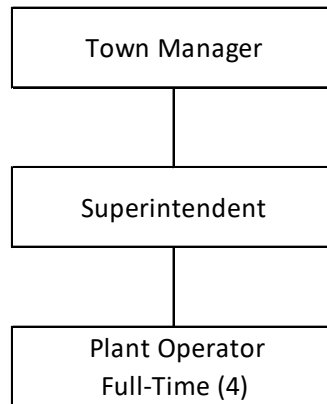

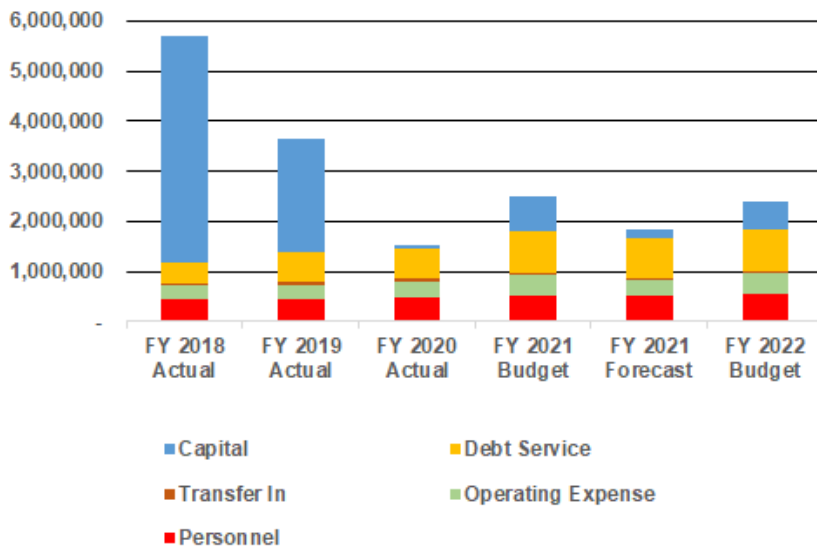
